



# Surrey Police Competition Terms and Conditions

## Safer Internet Day (12–18 year olds)

### 1 The Promoter

The promoter is: The Chief Constable of Surrey Police at Surrey Police, PO BOX 101, Guildford, Surrey, GU1 9PE ("Surrey Police").

### 2 The competition

- 2.1 The title of the competition is "Safer Internet Day".
- 2.2 "Safer Internet Day" is being held on Tuesday 7 February 2023. This year's theme is '*Want to talk about it? Making space for conversations about life online.*'
- 2.3 Surrey Police is holding this competition for the best poster, video, animation, or even a song that helps promote the safe, responsible and positive use of digital technology for children and young people.

### 3 Competition Dates

The competition will run from 9:00am on 17 January 2023 (the "**Opening Date**") to 11:59pm on 7 February 2023 the "**Closing Date**") inclusive.

### 4 Eligibility

- 4.1 The competition is open to all children who attend a school in the county of Surrey and who are aged between 11 and 18 years old (inclusive) during the period from the Opening Date to the Closing Date ("**Schools**").
- 4.2 The competition allows a maximum of one entry per person.

### 5 Content

- 5.1 Entrants have discretion over the type of media content created for the competition (subject to the entries complying the requirements of these terms) and can include posters, animations, videos, artwork, songs or music ("**Content**").
- 5.2 Content should focus on "Safer Internet Day" with the theme '*Want to talk about it? Making space for conversations about life online.*'

- 5.3 Content should focus on the key values and aims of “Safer Internet Day”:
- 5.3.1 promoting safe, responsible and positive use of digital technology by children;
  - 5.3.2 helping children understand how to use the internet and technology safely;
  - 5.3.3 helping children understand what amounts to respectful behaviour online;
  - 5.3.4 helping children understand what to do if they encounter hate or bullying directed at them or someone else; and
  - 5.3.5 helping children enjoy using the internet and technology in line with the above values.
- 5.4 Content must not:
- 5.4.1 include footage or imagery or other people without their express permission;
  - 5.4.2 be defamatory of any person;
  - 5.4.3 be obscene, offensive, hateful or inflammatory;
  - 5.4.4 bully, insult, intimidate or humiliate;
  - 5.4.5 promote sexually explicit material;
  - 5.4.6 include child sexual abuse material.
  - 5.4.7 promote violence;
  - 5.4.8 promote discrimination based on race, sex, religion, nationality, disability, sexual orientation or age;
  - 5.4.9 use other’s materials – including branding or logos;
  - 5.4.10 be likely to deceive any person.
  - 5.4.11 promote any illegal content or activity;
  - 5.4.12 include any political content;
  - 5.4.13 be in contempt of court;
  - 5.4.14 be threatening, abuse or invade another's privacy, or cause annoyance, inconvenience or needless anxiety;
  - 5.4.15 be likely to harass, upset, embarrass, alarm or annoy any other person;
  - 5.4.16 impersonate any person;
  - 5.4.17 advocate, promote, incite any party to commit, or assist any unlawful or criminal act such as (by way of example only) copyright infringement or computer misuse;
  - 5.4.18 contain images of celebrities, or images created that clearly depict celebrities

- 5.5 Content should be submitted to Surrey Police in the following formats (i) Jpeg, (ii) Png or (iii) MP4 files can be accepted up to the file size of 2GB via [we.transfer.com](https://we.transfer.com)

## **6 Who submits the entries?**

- 6.1 Competition entries are to be submitted with the permission of the child's parent/guardian.
- 6.2 The entry needs to include:
- 6.2.1 the child's name;
  - 6.2.2 confirmation that the child attends a school in the county of Surrey;
  - 6.2.3 confirmation from the parent or guardian of the child that they agree to the competition terms in respect of their child's entry to the competition; and
  - 6.2.4 the parent/guardians contact information, which will be used to contact in the case of any queries about entries, or to notify if their child's entry is successful.
- 6.3 Parents/guardians must check that all entries (including the Content) comply with the provisions of these terms before submission.
- 6.4 By submitting any entry to the competition, the parents/guardians confirm they are entitled to submit the entry on behalf of the child.
- 6.5 Surrey Police may require the parent/guardian to provide proof that the relevant child is eligible to enter the competition in order that the Prize can be claimed.
- 6.6 By submitting a competition entry, the parent/guardian is agreeing to be bound by these terms and conditions.

## **7 How to submit the entries**

- 7.1 Competition entries should be submitted by the parent/guardian as set out in this clause 7:
- 7.2 Competition entries must be received by Surrey Police by no later than 5:00pm on the Closing Date. All competition entries received after the Closing Date are automatically disqualified.
- 7.3 Competition entries can be submitted as follows:
- 7.3.1 by post to Corporate Communications at Surrey Police, PO BOX 101, Guildford, Surrey, GU1 9PE; or

- 7.4 Surrey Police will not accept:
- 7.4.1 responsibility for competition entries that are lost, mislaid, damaged or delayed in transit, regardless of cause, including, for example, as a result of any postal failure, equipment failure,

technical malfunction, systems, satellite, network, server, computer hardware or software failure of any kind; or

7.4.2 proof of posting or transmission as proof of receipt of entry to the competition.

## **8 How entries are judged**

8.1 The competition entries will be judged the Surrey Police media and communications team based on which entry (including the Content) best reflects the values and aims of Safer Internet Day as set out at clause 5.3 above.

8.2 The decision of the Surrey Police media and communications team (acting reasonably) will be final.

## **9 The Prize**

9.1 The prize is a £25 Cineworld voucher ("**Prize**").

9.2 There is no cash alternative for the Prize.

9.3 The Prize is not negotiable or transferable.

9.4 Surrey Police reserves the right to replace the Prize with an alternative prize of equal or higher value if circumstances beyond Surrey Police's control makes it necessary to do so.

## **10 Winner**

10.1 Surrey Police will announce the winning entry on 10 February 2023 ('**Announcement Date**').

10.2 Surrey Police will contact the parent/guardian of the winning entry no later than 9 February, using the contact details provided with the competition entry.

## **11 Winner's Details**

11.1 Surrey Police must either publish or make available information that indicates that a valid award took place.

11.2 To comply with this obligation Surrey Police will publish the surname (but not first name), county of the Prize winning pupil and winning entry on the Surrey Police Facebook page at [www.facebook.com/SurreyPolice](https://www.facebook.com/SurreyPolice) on the Announcement Date.

11.3 If the parent or guardian has an objection to the child's surname, county and winning entry being published or made available, please contact Surrey Police at [Competition2@surrey.police.uk](mailto:Competition2@surrey.police.uk). In such circumstances, Surrey Police must still provide the information and winning entry to the Advertising Standards Authority on request.

## **12 Claiming the Prize**

12.1 The Prize shall be sent to the winner using the contact details provided on the entry form. Please allow 30 days for delivery of the Prize from the Announcement Date.

12.2 The Prize may not be claimed by a third party on the child's behalf (other than the child's parents or guardians).

12.3 Surrey Police will make all reasonable efforts to contact the parent/guardian of the winner. If the relevant parent/guardian cannot be contacted or is not available or has not claimed the Prize within 30 of days of the Announcement Date, Surrey Police reserves the right for the Surrey Police judging panel to select another winner based on the process set out at clause 8 from the valid entries that were received before the Closing Date.

12.4 Surrey Police does not accept any responsibility if the child is not able to take up the Prize.

### **13 Limitation regarding the Prize**

13.1 The Prize is being provided to Surrey Police by a third-party supplier.

13.2 Surrey Police will not be liable to the winner of the Prize for any loss, damage, personal injury or death occurring as a result of taking up the Prize, except where it is caused by its negligence.

13.3 Where any issues arise with the Prize, please let us know. Surrey Police will then liaise with the third-party supplier. Your statutory rights are not affected.

### **14 Ownership and use of competition entries**

14.1 Parents/guardians in relation to each entry submission is agreeing to Surrey Police's use of the competition entries as set out in this clause 14.

14.2 Competition entries shall remain the property of the relevant pupil entrant (or their parents or guardians, as applicable).

14.3 Without impacting upon clause 14.2, Surrey Police shall be entitled for a period of three years following the Announcement Date ("Use Period") to:

14.3.1 make competition entries (including the Content) available on its website [www.surrey.police.uk](http://www.surrey.police.uk);

14.3.2 use the competition entries (including the Content) on any of Surrey Police's social media; or

14.3.3 use the competition entries (including the Content) to send to local media outlets and in any manner which Surrey Police decides to do so.

14.4 Surrey Police's right to use the competition entries (including the Content) shall be on a non-exclusive, worldwide, non-cancellable licence basis for the Use Period and includes the right to display, publish, transmit, copy, edit, alter, store, re-format and sub-licence the competition entry and any accompanying materials for the purposes set out at clause 14.3.

### **15 Data protection and publicity**

15.1 Surrey Police will only process personal information provided by the School (whether in relation to teach or pupil entrants) as set out in the Privacy Policy [www.surrey.police.uk/hyg/fpnsurrey/privacy-notice/](http://www.surrey.police.uk/hyg/fpnsurrey/privacy-notice/).

15.2 See also clause 11 with regard to the announcement of winners.

## **16 General**

- 16.1 If there is any reason to believe that there has been a breach of these terms and conditions, Surrey Police may, at its sole discretion, reserve the right to exclude the relevant entry or entries from participating in the competition.
- 16.2 Surrey Police reserves the right to hold void, suspend, cancel, or amend the prize competition where it becomes necessary to do so.
- 16.3 These terms and conditions shall be governed by English law, and the parties submit to the exclusive jurisdiction of the courts of England and Wales.
